1. With respect to the Elections of TELANGANA ELECTRICITY ENGINEERS' ASSOCIATION (Regd. - c) The contestant must enclose a copy of Life membership card/membership receipt or a certificate from the concerned Branch Secretary/Treasurer or Secretary Finance of TEEA that they are valid members of the Association.
- d) The member(s) proposing for any post shall be valid member(s) of the Association and shall be eligible to cast the vote for that particular post.
